SECTION 4 : FIRST AID MEASURES

4.1 DESCRIPTION OF FIRST-AID MEASURES AND MAIN SYMPTOMS AND EFFECTS, ACUTE AND DELAYED:

SECTION 5 : FIRE-FIGHTING MEASURES

5.1 EXTINGUISHING MEDIA:
Extinguishing powder or CO2. In the case of more important fires, also alcohol resistant foam and water spray/mist. Do not use for extinguishing: direct water jet. Direct water jet may not be effective to extinguish the fire, since the fire may spread.

5.2 SPECIAL HAZARDS ARISING FROM THE SUBSTANCE OR MIXTURE:
Decomposes when heated intensely. Fire can produce a dense black smoke. As consequence of combustion or thermal decomposition, hazardous products may be produced: carbon monoxide, carbon dioxide, nitrogen oxides. Harmful. Irritant. Exposure to combustion or decomposition products may be a hazard to health.

5.3 ADVICE FOR FIREFIGHTERS:
Special protective equipment: Depending on magnitude of fire, heat-proof protective clothing may be required, appropriate independent breathing apparatus, gloves, protective glasses or face masks and boots. Eliminate possible sources of ignition and when appropriate, ventilate the area. Do not smoke. Avoid direct contact with this product. Avoid breathing vapours. Keep people without protection in opposition to the wind direction.

Avoid contamination of drains, surface or subterranean water and soil. In the case of large scale spills or when the product contaminates lakes, rivers or sewages, inform the appropriate authorities in accordance with local regulations.

EXPOSURE CONTROLS:

ENGINEERING MEASURES:



Provide adequate ventilation. Where reasonably practicable, this should be achieved by the use of local exhaust ventilation and good general extraction. If these measures are not sufficient to maintain concentrations of particulates and vapours below the Occupational Exposure Limits, suitable respiratory protection must be worn.
