SECTION 4 : FIRST AID MEASURES

4.1 DESCRIPTION OF FIRST-AID MEASURES:

SECTION 5 : FIRE-FIGHTING MEASURES

5.1 EXTINGUISHING MEDIA:

Extinguishing powder or CO₂. In the case of more important fires, also alcohol resistant foam and water spray/mist. Do not use for extinguishing: direct water jet. Direct water jet may not be effective to extinguish the fire, since the fire may spread.

5.2 SPECIAL HAZARDS ARISING FROM THE SUBSTANCE OR MIXTURE:

Fire can produce a dense black smoke. As consequence of combustion or thermal decomposition, hazardous products may be produced: carbon monoxide, carbon dioxide. Irritant. Exposure to combustion or decomposition products may be a hazard to health.

EXPOSURE CONTROLS:

ENGINEERING MEASURES:



Provide adequate ventilation. Where reasonably practicable, this should be achieved by the use of local exhaust ventilation and good general extraction. If these measures are not sufficient to maintain concentrations of particulates and vapours below the Occupational Exposure Limits, suitable respiratory protection must be worn.
